

MARION ROAD GUN CLUB, INC.

BY-LAWS

1. The Club's "Safety Rules" and By-Laws will be obeyed by all present on the range. These rules will be given to each new club member, along with the membership card, (badge), and will be posted at the club range. Blatant disregard of safety rules shall be grounds for dismissal from club membership.
2. When work for the club is determined necessary by a majority vote of the members present at a club meeting, a "work day" will be declared for the purpose of its accomplishment if it falls within the ability of the members to accomplish same and does not require "contracting out". The work day date and time will be posted in the "Bullet" (club publication). Those members that report at the stated time, bringing appropriate tools for accomplishment of the work at hand, and diligently apply themselves to the accomplishment of the objective shall be noted by the person overseeing the work, and their names shall be turned in to the Secretary-Treasurer who will keep a record thereof and decrease the next year's dues by the amount of \$5.00, for each such day of participation by the club members.
3. The club will publish a monthly bulletin to each member by mail, or if the member wishes, by electronic (computer) transmission (e-mail). The issuance of this publication shall be the responsibility of the Secretary/Treasurer.
4. There will be from time to time, projects for which it is not necessary to ask for volunteers in a regular "work day", and for which there is a volunteer, or volunteers willing to accomplish the task at hand in an expeditious manner. The project may require the acquisition of materials, which must be purchased for accomplishment of the job. It shall be within the authority of the Secretary/ Treasurer to reimburse the volunteer(s) for these materials, which were purchased by them, provided that the total dollar amount involved is \$50.00 or less. With the added approval of the club President, or Vice President, acting in the unavailability of the President, this amount may be reimbursed by the Secretary/Treasurer to the volunteer(s) doing the work, up to and including \$150.00. There shall be no need for taking a vote at club meeting on the matter required.
5. Non-members who have been guests at the club range twice must apply for membership if they wish to have further access to the range (through membership). Otherwise, they may no longer come to the range as guests. If membership is denied such a person, they may no longer come to the range as anyone's guest.

6. If and when a “club match” is to be held, there will be designated one of the members as “Match Captain”, who will have the authority for the conduct of the match and for making the arrangements necessary thereof. Non –club members may be invited to the match if the Match Captain so desires, but they will be subject to any club requirements regarding guests, except that they may number more than” two” if the Match Captain has enough assistants to properly oversee the guests. All non-member shooters must sign a waiver of liability before they participate in the match.

7. Changes to the By-Laws may be made by a simple majority vote of those members attending a club meeting provided that it shall have been advertised in the “ Bullet” (club publication), including the text of the proposed change to the By-Laws, prior to the meeting whereat the vote is to be taken.

8. The election of club officers shall be accomplished annually in accordance with the Constitution of the Marion Road Gun Club, Inc.

9. Club dues will be on an annual basis starting with the first day of the calendar year and ending with the last day of the calendar year. Dues for an individual paying same, may be reduced commensurate with any accumulated reduction stemming from the member’s participation in club work days the previous year, as accounted for by the Secretary/Treasurer: Current Dues are:

A. Individual Adult Member, aged 18 through 64 as of the date of application for membership- \$ 80.00

B. Individual Senior Member, aged 65 or older as of the date of application for membership-\$50.00

C. Individual Junior Membership, (Must be at least 7 years old, and not more than 17 years of age as of the date of application for membership, and must reside with their parent(s) / Guardian(s) who are themselves Individual Adult Member(s), or a parent who is an Individual Adult Member who has legal Rights of Visitation with the child that is to be an Individual Junior Member. Individual Junior Members will not be allowed on the range without being, at all times, under the direct supervision of the Individual Adult Member(s) aforesaid. -\$20.00

D. There will be no proration of dues for persons joining the club during the calendar year.

10. No children under 7 years of age will be allowed on the range at any time.

11. All persons using the range shall have and use eye and ear protection when the range is in use.

12. No one under 21 years of age will be allowed to handle or fire pistols or fully automatic weapons on the range, except under the direct supervision of a club member of 21 years of age or older.

13. All shooters will bring their own targets on appropriate cardboard or stands and will remove them from the range when their shooting ends. Shooting at trees and posts or bottles, and like objects that leave debris, is prohibited. What You bring with You, take with You or put it in the garbage cans furnished at the range.

14. The Secretary Treasurer shall be paid a monthly salary as determined by a vote of the members of the MRGC. This is currently set at \$250.

15. Every member must wear their membership badge in an easily visible manner while on the range property. Guests of any member must also wear their guest badge in the same manner.
